Permission to Use Image/Vocal Recording in Picture, Video and Podcast



I hereby give the Arcadia Public Library & Nuvein Foundation for Literature and the Arts the right and permission to publish, copyright and use pictures, images, video portrayals and vocal recordings of the participant in which he/she may be included in whole or in part, composite or retouched in character or form.

- A) The foregoing shall include, without limitation, the unrestricted right and permission to copyright and use, re-use, publish, and republish vocal recordings, photographic portraits or pictures and video portrayals of the participant or in which he/she may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with his/her own or a fictitious name, or reproduction hereof in color or otherwise, made through any and all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose whatsoever.
- B) I also permit the use of any printed material in connection with the foregoing.
- C) I hereby relinquish any right I might otherwise have for compensation for use of my pictures, image, vocal recordings, or video portrayals by the Arcadia Public Library and Nuvein Foundation for Literature and the Arts in printed materials, video, etc.
- D) I hereby relinquish any right that I may have to examine or approve the completed product or products or the advertising copy or printed matter that may be used in conjunction therewith or the use to which it may be applied.
- E) I hereby release, discharge and agree to save harmless **[The City of Arcadia, Arcadia Public Library and Nuvein Foundation for Literature and the Arts]**, their officials, officers, employees, agents, legal representatives and assigns, and all persons functioning under its permission or authority, or those for whom it is functioning, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.
- F) I hereby affirm that I am the legal guardian of the participant. I have read the above authorization, release and agreement, prior to its execution. I fully understand the contents thereof. This agreement shall be binding upon me and my heirs, legal representatives and assigns.
